## KWBW Rules for Christmas Two-Of-A-Kind

HOW TO PLAY: "Christmas Two-of-a-Kind" is a game of memory. Listeners are encouraged to view, download or print the helpful "Official Game Board" located on the station website at http://www.bwradio.biz/. We will also have a starter gameboard available to pick up in person at our studios at 825 North Main Hutchinson, KS. No game boards can be mailed. Listeners then may participate by listening to KWBW-AM/FM weekday mornings between 8:30am and 10am and by being the correct caller to (620) 669-8888 when prompted to call. On each turn on-air, a player will be asked to designate two numbers from the game board grid to be revealed. A corresponding sponsor and prize for both numbers will be announced by the KWBW host. If the player successfully matches a pair of advertisers/prize, the player wins that prize. At that point, the play will end. When a player turns over two numbers that do NOT match a pair of advertisers/prize, those prizes are NOT awarded, and that player's turn is over. When all the pairs have been SUCCESSFULLY MATCHED, the contest ends and the players keep all their prizes from the winning advertisers. In addition, prize winners and NON-winners will ALL become eligible to win the \$500 grand prize random drawing to be held on Dec. 21<sup>st</sup>, or at an earlier date to be announced if the contest ends early.
